### Can I apply?

#### Admission requirements

The University's [Admission Policy](#) will apply.

To be eligible for admission to the Bachelor of Urban and Environmental Planning (Honours), the following requirements must be met:

- A minimum overall GPA of 5.5 for the courses listed in Years 2 and 3 of the [Bachelor of Urban and Environmental Planning \(1086\)](#) or [Bachelor of Urban and Environmental Planning \(1279\)](#).
- Completion of [4029ENV Project Proposal for Honours](#), a mandatory course for the [Bachelor of Urban and Environmental Planning \(Honours\) \(1431\)](#).

#### Language requirements

#### How to apply

Eligible students may apply for this Honours program up to and including Trimester 2-2024. From Trimester 1-2025, commencing students are referred to the [Bachelor of Urban Planning \(Honours\) \(1658\)](#).

### What are the language requirements?

## Language requirements

English language requirements apply to International applicants and other applicants whose previous study was undertaken in a language other than English. The minimum English language requirements for such applicants for entry to this program are as follows:

- A minimum overall band score of 6.5 on IELTS (Academic) with no sub-score of less than 6.0
- *OR* a minimum score of 575 on TOEFL
- *OR* an internet-based (iBT) TOEFL score of 79 (no sub-score less than 19)
- *OR* no score less than 3+ in each skill of the ISLPR (conducted by ISLPR Language Services only)
- *OR* a minimum overall score of 176 (no score less than 169) on C1 Advanced (formerly Cambridge Certificate in Advanced English) **or** C2 Proficiency (formerly Cambridge Certificate of Proficiency in English)
- *OR* an overall score of 58 in the Pearson Test of English (Academic) with no score less than 50.

English test results must be no more than two years old.
