As part of your degree, you can experience several industry placements with experts in the field, letting you put your skills and knowledge into practice in an authentic environment.


Graduate outcomes

This program is offered in full-time on-campus at the Gold Coast.

The program incorporates 80 hours of compulsory work-integrated learning (WIL) in community sport and recreation facilities within the course [3434AHS Sport Development Practicum](#).

Additional attendance information

[3011AHS Fitness Practicum I](#) and [3012AHS Fitness Practicum II](#) are delivered with TAFE Queensland. All studies are conducted off campus at TAFE Queensland - Gold Coast and at external workplaces. Note, there are limited places available for enrolment in these courses.

If you are an International student on a student visa, you must ensure that you enrol in a way that will allow you to complete your enrolment within the expected program duration as stated on your Confirmation of Enrolment (CoE).

Work-integrated learning

Work-integrated learning activities integrate theoretical learning with its application in the workplace. The inclusion of work-integrated learning activities in this degree program demonstrates Griffith's commitment to preparing its graduates for success in their working life.

Work integrated learning in this program is undertaken in the 10 credit point core course [3434AHS Sport Development Practicum](#) which is completed in Year 3 of the program and will be managed within School and Health Group policies and processes. Students will complete 80 hours of compulsory fieldwork (WIL).

Placement requirements

Professional Practice requirements

There are placements associated with this program and before undertaking professional experience placements, all students in this program are required to have completed the following by the end of their first trimester of study:

- Vaccinations and Health Tests
- Licenses and Certificates
- Online Training
- Health Placement Requirements

What are the fees?

International students

An International student is one who is not:

- an Australian or New Zealand citizen or
- a Pacific Engagement visa holder or
- a person who has Australian permanent resident status.

Indicative annual tuition fee

The indicative annual tuition fee is calculated based on a standard full-time study load which is usually 80 credit points (two full-time trimesters).

The indicative annual tuition fee is based on current conditions and available data and should only be used as a guide. These fees are reviewed annually and are subject to change.

Tuition fees

- An International student pays tuition fees.
- Students are liable for tuition fees for the courses they are enrolled in as at the census date.
- The tuition fee for students who commence their program prior to 2014 is charged according to the approved program fee for the trimester in which the student commenced the program.
- The tuition fee for students who commence their program from 2014 onwards is charged according to the approved program fee for the trimester in which the student is enrolled.

Changing programs

If an International student changes to a different program they will be subject to the approved program fee for the trimester in which they are enrolled.

Permanent resident status

If an **undergraduate student** obtains permanent resident status in Australia after commencing study in a program, and the student can provide evidence of permanent resident status prior to the census date (of the trimester in which they are enrolled), the student will be provided with a domestic fee-paying place.

The student may then apply for a Commonwealth supported place at the next admission period provided that the student satisfies the conditions for transfer from a domestic fee-paying place to a Commonwealth supported place as set out in the [Undergraduate Programs Admission Policy](#).

If a **postgraduate student** obtains permanent resident status in Australia after commencing study in a program, and the student can provide evidence of permanent resident status prior to the census date (of the trimester in which they are enrolled), the student will automatically be considered for a Commonwealth supported place (subject to availability) or a domestic fee-paying place as applicable for the program.

If a **research student** obtains permanent resident status in Australia after commencing study in a program, and the student can provide evidence of permanent resident status prior to the census date (of the trimester in which they are enrolled), the student will automatically be considered for a Commonwealth Government Research Training Program (RTP) Fee Offset or a domestic fee-paying place as applicable for the program.
