Degree requirements: Students who started Trimester 2 - 2024

For the award of *Bachelor of Laws (Honours)/Bachelor of Business [LLB (Hons)/BBus]*, you must successfully complete 400 credit points, made up of the core courses AND

- 60 credit points of listed Law electives AND
- 60 credit points for a Business major and 30 credit points of free-choice electives OR
- 80 credit points for an extended Business major and 10 credit points of free-choice electives OR
- 90 credit points for an Accounting (extended) major.

Other program requirements

You must successfully complete:

- no more than 120 credit points of Level 1 courses (the first digit of a course code denotes the level);
- at least 60 credit points of Level 3 courses or higher.

Bachelor of Business

This degree may be awarded **with Distinction** where a student achieves a minimum program GPA of 6.5 with no failed courses. The words "This award was achieved with Distinction" will be recorded on the testamur.
