The Graduate Certificate in Early Childhood Education and Care is designed to provide qualified registered teachers the opportunity to teach in pre-school settings (1-5 years) as well as specialise in the early years of school (5-8 years) to enhance their development as a professional.

Taking a leave of absence from this program is permitted, subject to conditions outlined in the Enrolment Procedure

#### Work-integrated learning

Students in this program must undertake:

- a minimum of 10 days professional experience with children aged birth to 2 years,
- 40 days working with children 2 to 5 years; and
- 10 days in a 5 to 8 years setting; students who have completed an initial teacher primary education program may be exempt from completing this requirement.

## What are the fees?

### Commonwealth supported students

- The indicative fee represents the expected average fee for an annual full-time study load (80 credit points). A student's actual annual fee may vary in accordance with his or her choice of majors and electives. The Australian Government sets student contribution amounts on an annual basis.

### Fee-paying postgraduate (domestic) students

#### Indicative annual tuition fee

The indicative annual tuition fee is calculated based on a standard full-time study load which is usually 80 credit points.

The indicative annual tuition fee is based on current conditions and available data and should only be used as a guide. These fees are reviewed annually and are subject to change.

#### Tuition fees

- A fee-paying postgraduate student pays tuition fees.
- Students are liable for tuition fees for the courses they are enrolled in as at the census date.
- The tuition fee for students who commence their program prior to 2014 is charged according to the approved program fee for the trimester in which the student commenced the program.
- The tuition fee for students who commence their program from 2014 onwards is charged according to the approved program fee for the trimester in which the student is enrolled.

#### Additional fee information

This postgraduate program has Commonwealth Supported Places. If you are eligible, the Australian Government will contribute to the cost of this program but you will also be required to make a contribution.
