Degree requirements: Students who started Trimester 2 - 2020

To be eligible for the award of *Master of Public Administration (MPA)*, a student must acquire 120 credit points as prescribed below:

Related Bachelor degree or higher (4.5

- gain a minimum 60 credit points and a maximum of 80 credit points for core courses and
- gain 40 credit points for listed electives or the dissertation pathway and
- gain a maximum of 20 credit points of additional listed electives.

To be eligible for the award of *Master of Public Administration (MPA)*, a student admitted with **40 credit points of advanced standing** must acquire 80 credit points as prescribed below:

- gain 40 credit points for core courses and
- gain 40 credit points for listed electives or the dissertation pathway and gain a maximum of 20 credit points of additional listed electives.

This degree may be awarded **with Distinction** where a student achieves a minimum program GPA of 6.5 with no failed courses. The words "This award was achieved with Distinction" will be recorded on the testamur.

Exit point

To be eligible to exit this Masters program with the Graduate Diploma of Public Administration award, a student must acquire 80 credit points of core courses. Note: Students who exit with the Graduate Diploma will not be eligible for re-admission to complete the Master of Public Administration.

To exit, a student should apply for a program transfer.
