Can I apply?

Admission requirements

To be eligible for admission to the **Master of Public Administration**, a student must:

- hold a related Bachelor degree (or higher) from a recognised University (or another tertiary education institution of equivalent standing) with a minimum Grade Point Average (GPA) of 4.5 (using a 7.0 scale), OR
- hold a Griffith Graduate Certificate in Policy Analysis (or equivalent) with a minimum Grade Point Average (GPA) of 4.5 (using a 7.0 scale). Students with a Griffith Graduate Certificate in Policy Analysis will receive 40 credit points of advanced standing, OR
- hold a Griffith Graduate Certificate in Integrity and Anti-Corruption (or equivalent) with a minimum Grade Point Average (GPA) of 4.5 (using a 7.0 scale). Students with a Griffith Graduate Certificate in Integrity and Anti-Corruption will receive 40 credit points of advanced standing, OR
- have a combination of alternative admission criteria such as formal, informal and non-formal learning deemed to be equivalent to one of the above.

Language requirements

What are the language requirements?

Language requirements

English language requirements apply to International applicants and other applicants whose previous study was undertaken in a language other than English. The minimum English language requirements for such applicants for entry to this program are as follows:

- A minimum overall band score of 6.5 on IELTS (Academic) with no sub-score of less than 6.0
- OR a minimum score of 575 on TOEFL
- OR an internet-based (iBT) TOEFL score of 79 (no sub-score less than 19)
- OR no score less than 3+ in each skill of the ISLPR (conducted by ISLPR Language Services only)
- OR a minimum overall score of 176 (no score less than 169) on C1 Advanced (formerly Cambridge Certificate in Advanced English) **or** C2 Proficiency (formerly Cambridge Certificate of Proficiency in English)
- OR an overall score of 58 in the Pearson Test of English (Academic) with no score less than 50.

English test results must be no more than two years old.

International students who successfully complete the **Direct Entry Program (DEP)** will satisfy the English Language requirements for this Griffith degree.

The Direct Entry Program (DEP) is not available for Domestic students.
