This program is offered full-time and part-time in online mode only.

Student Income Support

To be classed as a full-time student, you are required to enrol in a minimum number of credit points each standard study period. The minimum credit points for full-time enrolment in this program is 30 credit points.

Trimester 1 and Trimester 2 are deemed standard study periods. As Trimester 3 is a non-standard study period, continuing students moving from one year to the next will not be required to study during this trimester to be eligible for student income support.

Domestic students who commence in Trimester 3 may be eligible for student income support from the onset of study provided they are enrolled full-time in this study period.

Students who complete the dissertation component will have a pathway to Higher Degree Research study. Graduates who wish to continue on to Higher Degree Research study and have not completed the dissertation component will be able to apply for entry to the [Graduate Diploma of Health Research \(4161\)](#) which provides the necessary preparation for entry into the Doctor of Philosophy (PhD) or Master of Philosophy (MPhil) programs.

What are the fees?

Commonwealth supported students

Fee-paying postgraduate (domestic) students

Indicative annual tuition fee

The indicative annual tuition fee is calculated based on a standard full-time study load which is usually 80 credit points.

Tuition fees

- A fee-paying postgraduate student pays tuition fees.
- Students are liable for tuition fees for the courses they are enrolled in as at the census date.
- The tuition fee for students who commence their program prior to 2014 is charged according to the approved program fee for the trimester in which the student commenced the program.
- The tuition fee for students who commence their program from 2014 onwards is charged according to the approved program fee for the trimester in which the student is enrolled.

Additional fee information

This postgraduate program has **Commonwealth Supported Places**. If you are eligible, the Australian Government will contribute to the cost of this program but you will also be required to make a contribution.
