### Can I apply?

#### Admission requirements

To be eligible for admission to this program, a student must fulfil the following criteria:

- hold a Bachelor degree in medical science, biological science, pharmaceutical science or a related health discipline from Griffith University or from another university or institution with a GPA of at least 5 (using a 7-point scale) or equivalent.

In addition to the academic qualifications required for candidature as described above, the following criteria needs to be satisfied:

- the proposed topic is appropriate for higher degree research and consonant with the academic aims and objectives of the pathway selected
- there are two qualified members of staff holding confirmed, continuing or fixed term appointments of sufficient length for the purposes of supervision
- the Pathway Advisor is able to provide the necessary research place, supervision, resources and facilities; and there is an appropriate fit between the applicant, research environment, available resources and supervision
- the provision of educational services consequent upon approval of the application for candidature will not expose the University to a risk of contravening any applicable law, including any international embargoes, sanctions or controls which regulate the University's operations from time to time, and
- the proposed program of work can be completed within the maximum period of candidature for the degree.

Applicants are required to find a suitable supervisor and have their research project approved. Applicants are advised to contact the relevant Pathway Advisor who will provide assistance in finding a suitable supervisor and developing a research proposal. Those nominating a supervisor who is not a Griffith University staff member in the supervising pathway must arrange a co-supervisor from within the selected pathway (i.e. Medical Science, Medicine, Pharmacy).

Applicants to this program are not eligible to apply for a Griffith University Postgraduate Research Scholarship (GUPRS) or Griffith University International Postgraduate Research Scholarship.

## What is the application process?

### How to apply

An International student is a person who is not an Australian or New Zealand citizen or an Australian permanent resident or holder of an Australian Permanent Humanitarian visa. International students study on a fee-paying basis and they must pay the full cost of their education through tuition fees either directly or through a third party (sponsor, government etc). International students will require a student visa in order to study in Australia.

### Application preparation

To prepare for completing your application online, you will need to:

- check the Admission and English Language Proficiency requirements to find out if you are academically qualified to apply for this program;
- check any program fees applicable to you if you were to undertake this program;
- develop a proposed Research Topic and Research Proposal in your area of interest;
- identify at least one potential Griffith supervisor who has reviewed your Research Proposal and has agreed to supervise you;
- identify two Academic Referees who are willing to act as a Referee on your behalf;
- develop a Curriculum Vitae (CV).

## What are the language requirements?

### Language requirements

English language requirements apply to International applicants and other applicants whose previous study was undertaken in a language other than English.

All Higher Degree Research (HDR) applicants are expected to have reached an appropriate level of proficiency in English. International applicants must provide documentary evidence of their English Language Proficiency (ELP). Further, there may be occasions when a Head of Element or Dean feels it is appropriate to seek confirmation of ELP from applicants for whom there is no formal requirement to provide evidence of ELP (for example, Australian citizens or applicants with permanent resident status whose tertiary studies were not conducted in English or International applicants who have undertaken some studies in English). Full documentary evidence in support of English proficiency must be submitted with applications for candidature.

The minimum English Language proficiency requirements for applicants to **Higher Degree Research (HDR)** programs are as follows:

- A minimum overall band score of 6.5 on the IELTS (Academic) with no band score less than 6.0
- *OR* a minimum score of 575 on the paper-based TOEFL including a score of no less than 5.0 on the TWE

- *OR* a score of 79 on the internet-based (iBT) TOEFL with no sub-score less than 19
- *OR* a score of no less than 3+ in each skill of the ISLPR (conducted by ISLPR Language Services only)
- *OR* a minimum overall score of 176 (no score less than 169) on C1 Advanced (formerly Cambridge Certificate in Advanced English) **or** C2 Proficiency (formerly Cambridge Certificate of Proficiency in English)
- *OR* an overall score of 58 in the Pearson Test of English (Academic) with no score less than 50.

Only in-person tests are accepted.

English test results must be no more than two years old prior to the commencement of the program.

Applicants should be aware that these test scores are the minimum scores required by Griffith University for most disciplinary areas and that some elements may require higher levels of proficiency.

An applicant may be exempted from the requirement to provide an ELP test score if the applicant's tertiary level studies were completed within the specified timeframe and in one of the countries listed in the University's [Admission Schedule: English Language Proficiency](#).

An applicant may also be exempted from the requirement to provide an ELP test score if the applicant has completed at least two years full-time work experience in an English speaking professional work environment or has successfully completed the Griffith English Language Institute (GELI) Direct Entry Program (DEP) in accordance with the requirements as specified in the University's [Admission Schedule: English Language Proficiency](#).

The Direct Entry Program (DEP) is not available for Domestic students.
