About this program

You will study a wide ranging and diverse base of specialist health management courses. If you are a graduate or manager in health, aged or community care services and you want to develop your skills and understanding of contemporary health or social care management issues, these degrees will help you achieve your goals. Through flexible teaching and research options, you will learn about key areas of health sector policy, governance, operations and evidence-based practice management.

You will develop skills and knowledge in current management theory and practice, develop your leadership skills and style and gain an in-depth understanding of health workforce planning. You will also learn about managing human resources, planning and implementing health programs, and managing performance and health budgets from respected industry practitioners and academics. Additionally, you will develop skills in strategic decision making and change management and an understanding of the role of innovation and the application of technology in health services management. You will develop research and project management skills that will provide a sound basis for your current work role and your future endeavours.

Through a project directly relevant to your organisation's strategic direction, you will develop research and project management skills.

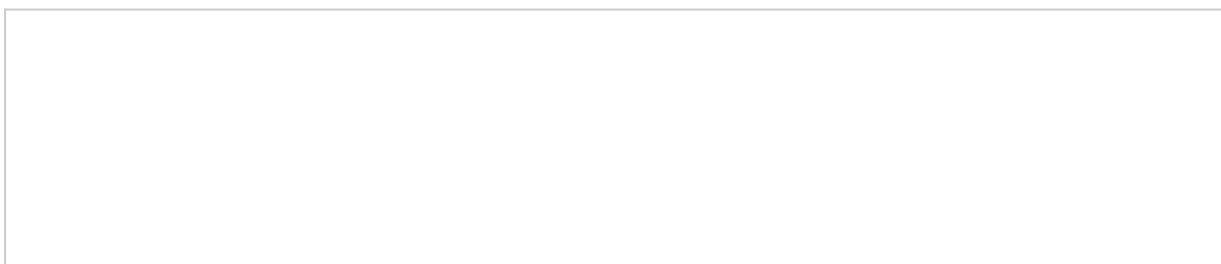
The **Master of Advanced Health Services Management offers** offers a range of different durations depending on your prior studies and work experience.

You may be eligible to complete this program in 2 years full time if you have:

- Bachelor, related discipline

You may be eligible to complete this program in 1.5 year full-time, (with 40 credit points of advanced standing) if you have:

- Bachelor Honours, related discipline **OR**
- Graduate Certificate, related discipline **OR**
- Graduate Diploma, related discipline

My attendance during the program

Attendance information

The Master of Health Services Management is offered full time and part-time online and at our South Bank campus.

You will be classed as a part-time student if you are enrolled in less than 30 credit points per trimester. As a part-time student, you will generally attend 6 hours of scheduled classes per week.

As a full-time student, you will generally attend 12 hours of scheduled classes per week throughout the trimester.

Classes may be scheduled during the day and evening throughout the week to accommodate part-time and working students unavailable to attend classes during the day.

International students residing outside Australia may enrol in this program. International students must be enrolled in at least 30 credit points per trimester.

The Master of Advanced Health Services Management is offered fully online. You can access course materials, participate in learning activities, lodge assessment items and access support services via the University's teach platform [Learning@Griffith](#). There is no requirement for on-campus attendance and access to a reliable computer with internet connection is essential. Internet-fully on-line, if it suits you, some courses may be taken at the South Bank campus.

If you are an International student on a student visa, you must ensure that you enrol in a way that will allow you to complete your enrolment within the expected program duration as stated on your Confirmation of Enrolment (CoE).

Work-integrated learning

The program provides the opportunity to undertake Work Integrated Learning (WIL) through full-time workplace placement in a healthcare organisation. The aim of Work-integrated learning (WIL) is to provide students with the opportunity to translate the content of the postgraduate program to the context of the workplace. This translation will occur with support from an academic supervisor and a workplace supervisor. The Work-integrated learning (WIL) component is a key to competency development as well as a translational learning opportunity. This experience will allow the student to develop the necessary attributes, skills and competencies expected in a health service management postgraduate professional. This Work-integrated learning (WIL) component offers a unique and exciting opportunity for students to work in contemporary healthcare facilities with health leaders and managers.

Work-integrated learning (professional placement) requires attendance in approved workplaces in Australia or internationally on a full-time basis during the Work-integrated learning (WIL) course.

Work-integrated learning activities integrate theoretical learning with its application in the workplace. The inclusion of work-integrated learning activities in the degree program demonstrates Griffith's commitment to preparing its graduates for success in their working life.

The work-integrated learning component of the program is designed as an opportunity to integrate the theoretical knowledge learned over the first two or three trimesters of the program. Accordingly, students may only undertake their industry placement after successful completion of the course work component of their degree program.

Students should be aware that the work-integrated learning component is undertaken across 13 weeks and is only available to students who have completed 80 credit points of courses. Students are required to complete Fit for Placement compliance requirements in the trimester prior to undertaking Work-integrated learning (WIL) and cannot progress on a Work-integrated learning (WIL) placement without this. Students will enrol in all four parts of the work-integrated learning course prior to undertaking the 13 week (390 hours) work-integrated placement and it is not available part-time.

There are placements associated with this program and before undertaking professional experience placements, all students in this program are required to have completed the following by the end of their first trimester of study:

- Vaccinations and Health Tests
- Licenses and Certificates
- Online Training
- Health Placement Requirements

What are the fees?

International students

An International student is one who is not:

- an Australian or New Zealand citizen or
- a Pacific Engagement visa holder or
- a person who has Australian permanent resident status.

Indicative annual tuition fee

The indicative annual tuition fee is calculated based on a standard full-time study load which is usually 80 credit points (two full-time trimesters).

The indicative annual tuition fee is based on current conditions and available data and should only be used as a guide. These fees are reviewed annually and are subject to change.

Tuition fees

- An International student pays tuition fees.
- Students are liable for tuition fees for the courses they are enrolled in as at the census date.
- The tuition fee for students who commence their program prior to 2014 is charged according to the approved program fee for the trimester in which the student commenced the program.
- The tuition fee for students who commence their program from 2014 onwards is charged according to the approved program fee for the trimester in which the student is enrolled.

Changing programs

If an International student changes to a different program they will be subject to the approved program fee for the trimester in which they are enrolled.

Permanent resident status

If an **undergraduate student** obtains permanent resident status in Australia after commencing study in a program, and the

student can provide evidence of permanent resident status prior to the census date (of the trimester in which they are enrolled), the student will be provided with a domestic fee-paying place.

The student may then apply for a Commonwealth supported place at the next admission period provided that the student satisfies the conditions for transfer from a domestic fee-paying place to a Commonwealth supported place as set out in the [Fees and Charges Procedure](#).

If a **postgraduate student** obtains permanent resident status in Australia after commencing study in a program, and the student can provide evidence of permanent resident status prior to the census date (of the trimester in which they are enrolled), the student will automatically be considered for a Commonwealth supported place (subject to availability) or a domestic fee-paying place as applicable for the program.

If a **research student** obtains permanent resident status in Australia after commencing study in a program, and the student can provide evidence of permanent resident status prior to the census date (of the trimester in which they are enrolled), the student will automatically be considered for a Commonwealth Government Research Training Program (RTP) Fee Offset or a domestic fee-paying place as applicable for the program.
