### Degree requirements: Students who started Trimester 2 - 2024

#### Pathway 1 (Standard)

To be eligible for the award of *Master of Professional Accounting (MProfAcc)*, a student must acquire 160 credit points as prescribed below:

- gain 120 credit points for core courses and
- gain 40 credit points for listed electives.

#### Pathway 2 (Advanced)

To be eligible for the award of Master of Professional Accounting (MProfAcc), a student admitted with **credit** must acquire 120 credit points as prescribed below:

- gain 60 credit points for core courses and
- gain 60 credit points for listed electives.

This degree may be awarded **with Distinction** where a student achieves a minimum program GPA of 6.5 with no failed courses. The words "This award was achieved with Distinction" will be recorded on the testamur.

#### Exit point

To be eligible to exit the Masters program with the Graduate Diploma of Professional Accounting award, a student must successfully complete 120 credit points of specified courses.

To exit, a student should apply for a program transfer.
