Pathways to further study

Students who complete a dissertation component will have a pathway to Higher Degree Research study. Graduates who wish to continue onto Higher Degree Research study and have not completed the dissertation component will be able to apply for entry to the [Graduate Diploma of Health Research \(4161\)](#) which provides the necessary preparation for entry into the Doctor of Philosophy (PhD) or Master of Philosophy (MPhil) program.

What are the fees?

Commonwealth supported students

Fee-paying postgraduate (domestic) students

Indicative annual tuition fee

The indicative annual tuition fee is calculated based on a standard full-time study load which is usually 80 credit points.

Tuition fees

- A fee-paying postgraduate student pays tuition fees.
- Students are liable for tuition fees for the courses they are enrolled in as at the census date.
- The tuition fee for students who commence their program prior to 2014 is charged according to the approved program fee for the trimester in which the student commenced the program.
- The tuition fee for students who commence their program from 2014 onwards is charged according to the approved program fee for the trimester in which the student is enrolled.

This postgraduate program has **Commonwealth Supported Places**. If you are eligible, the Australian Government will contribute to the cost of this program but you will also be required to make a contribution.
