### About this program

The Diploma of Arts is a pathway program designed to help you transition into the Bachelor of Arts. You'll develop foundational knowledge and skills in a supportive learning environment alongside your peers in the bachelor's degree, setting you up for success in your future studies.

You'll improve your creative thinking and communication skills to guide organisations through the complexities of modern life. Through a creative mix of critical thinking, innovation and collaboration, you'll gain the skills that employers of the future demand. You'll be guided and mentored by leaders in their field and learn how international and intercultural perspectives shape society.

In this diploma, you'll study academic foundation courses on communication and culture, academic writing, literary studies, and world history with additional support and access to a dedicated First Year Coordinator and (PASS) run by high-achieving students.

#### Attendance information

The Diploma of Arts may be undertaken full-time or part-time at either the Nathan or Gold Coast campus. A full-time student will generally attend 12 hours of scheduled classes per week throughout the trimester. Classes are generally scheduled during the day but some are offered during the evening between Monday and Friday.

#### Student Income Support

To be classed as a full-time student, you are required to enrol in a minimum number of credit points each standard study period. The minimum credit points for full-time enrolment in this program is 30 credit points.

Trimester 1 and Trimester 2 are deemed standard study periods. As Trimester 3 is a non-standard study period, continuing students moving from one year to the next will not be required to study during this trimester to be eligible for student income support.

## What are the fees?

### Commonwealth supported students

### Fee-paying undergraduate (domestic) students

These fees are only applicable to domestic students who are not Commonwealth supported including:

- Full-fee paying domestic students who commenced their program prior to 2009.
- International students who have been approved to pay domestic tuition fees after obtaining Australian or New Zealand citizenship or permanent residency or a permanent humanitarian visa and who have not obtained a Commonwealth supported place.

#### Tuition fees

- A fee-paying undergraduate student pays tuition fees.
- Students are liable for tuition fees for the courses they are enrolled in as at the census date.
- The tuition fee is charged according to the approved program fee for the trimester in which the student is enrolled.

#### FEE-HELP

Eligible undergraduate fee-paying students may defer their tuition fees by taking out a FEE-HELP loan which is part of the Higher Education Loan Program (HELP). Payment of the loan is via the taxation system when income reaches a specified level.
